- 1) Abstracts should be limited to one paragraph of 250-300 words. The total count of words does not include the title of the paper, author's name, designation and institutional affiliation.
- 2) Create the abstract with MS Word or compatible software with single space, using Times New Roman font of 12 point. No other format will be accepted. PDF documents will not be accepted.
- 3) The title of the abstract should be brief and precise and in bold using Times New Roman font of 14 point or similar.
- 4) Author(s) name(s) and affiliation(s) is/are written just below the title of the paper. Co-author(s) will also have to pay registration fee according to entitlement.
- 5) The first author/submitting author/ corresponding author should be the contacted author.
- 6) Presenting author's name should be marked by an asterisk (*).
- 7) Do not include illustrations or bibliographical references in the abstract.
- 8) Abstract should contain at least 5 keywords.
